

QUILTERS UNLIMITED ANNUAL MEETING JUNE 2, 2018

President Joyce Bounds presided and indicated her pleasure at visiting almost all of the chapters this year.

MINUTES: The minutes of the 2017 Annual Meeting were approved.

MONEY MATTERS: The budget is stable with strict rules regarding who can approve and spend money. The State has granted us non-profit status. More paperwork is required for the IRS. That is being prepared. The insurance for quilts in the show has been increased. Treasurer Mary Ansoff reported that QU's year to date revenue is \$88,082.92 of which \$63,216.90 is from show vendors and that we have a total of \$147,179.57 in cash as of June 2nd. As of Saturday night, the Boutique earned \$6,356.50, and we sold QU merchandise to the tune of \$4,060. This year's books will close on June 30th; so if you need reimbursement for any monies you have spent, get those in as soon as possible.

OUTREACH: There was a report on progress with the Outreach campaign whose aim is to make our presence well known and attract new members.

QUILT SHOW: Joyce reminded everyone of the Jelly Roll Race between chapters taking place on Sunday, June 3rd and the sewing machine give-away after the race. She mentioned that the shed inventory has been greatly reduced. Donna Hosek will head up next year's Quilt Show. The last show meeting will be on June 18th.

SOCIAL MEDIA: A reminder that social media accounts belong to the chapter and that the administration of any such accounts must be shared with the Chapter President.

IN MEMORIAM: Joyce mentioned the QU members who have passed on this year: Blanch Amman, Deb Godwin, Gene Ives, Linda Roberts, and Yvonne Weisner.

BOARD AND COMMITTEE MEMBERS: Joyce introduced and thanked the current QU Board members including all Chapter Presidents and thanked the members of the chapter (Centreville) in charge of this Annual Meeting. The In/Out Meeting for current and new Board Members and Chapter Presidents will be at 6:30 on June 27th at Quilters Studio.

FUTURE EVENTS: Rosemary Ryan announced that Karen Coombs will be the speaker for the Fall Event on September 27th. Attendance at her workshop will be determined by a lottery. Karen Eckmeier will be the speaker at next year's Annual Meeting. Rosemary made the presentation of a beach themed quilt to outgoing QU President Joyce Bounds.
